The 43rd annual production of A Christmas Carol brought in 15,215 and almost \$800,000 in revenue. All pre-show backstage tours were sold out, and this production continues to be a beloved holiday tradition for families in the Seattle area.

ACTLab had several successes throughout the year and reached 149% of its sales target with 7 of its 12 partners surpassing their goal. Attendance to the ACTLab was over 18,000. Highlights of the year were the second year of Ben de la Crème's Beware the Terror of Gaylord Manor which hit 129% of its goal; first-time partner and Seattle favorite, Dina Martina's Christmas Show had an outstanding run surpassing its goal by over \$61,000, and A Sensible Theatre Company's production of Pageant filled the Bullitt Cabaret for three weeks, exceeding its goal by \$21,000.
